J.J. Goicoechea

J.J. Goicoechea, DVM is a native Nevadan, raised in Eureka and attended the University of Nevada before being accepted into Colorado State University and earning his professional degree as a Doctor of Veterinary Medicine in 1999. From there he spent over twenty years practicing Veterinary Medicine in central Nevada and rural America.

From 2016 to 2019, he was the Deputy Administrator of the Animal Industry Division as well as the State Veterinarian for the Nevada Department of Agriculture then returned as the interim State Veterinarian in September of 2022.

He served as the Chairman of the Board of County Commissioners for ten years. He has also served as the Nevada Sagebrush Ecosystem Council Chair for a decade, President of the Nevada Veterinary Medical Association, and is a Board member of the Public Lands Council and NCBA Executive Committee, serving as Region 6 Vice President.

In January 2023, Dr. Goicoechea was appointed by Governor Lombardo as the Director of the Nevada Department of Agriculture where he leads the department in fulfilling its' mission to "preserve, protect, and promote Nevada Agriculture", after leaving local government in Eureka County.

When he is not doing business on behalf of the NDA, he can be found on his family's fourth-generation cattle ranch in White Pine and Elko Counties with his wife and two daughters, happily bringing up the fifth generation of ranchers.

Currently his research and extension program focuses management in the forage-based cropping systems of his region, and noxious weed control research wherever they may grow. He completed his technical training at Colorado state university obtaining a bachelor's degree in Forestry Management, and a master's degree in Weed science. When not working you will often find him with a fly rod in hand at one of the local lakes.

His presentation will focus on winter annual grass control at multiple sites, across multiple years with various herbicide applications. The effect of the treatments across time will be shared as well as the impacts to the desirable plant species on site.



James currently lives in Weatherford, Texas with his wife Everly and three children Macy, Madison and Cade.








Ed S. Kleiner

Following an Arts Degree in Economics at UNR, Ed opened his seed company 40 years ago. As company president, he has worked in most sectors of the reclamation industry from traditional mining ventures to new age solar projects. Focusing on supplying local genetic sources of seed for projects in the western Great Basin, he has supplied seed for the Carson City freeway, the I-580 corridor, the Southwest Intertie Project, the Tuscarora pipeline, as well as multiple projects in the Lake Tahoe Basin and the Truckee Meadows. Current sales emphasis includes urban drought tolerant landscape conversions and fire seedings. For the last 24 years he has been applying much of his experience to developing his 43 acre seed farm in Gardnerville, NV.

Ed will present on preservation of agricultural open space in the Carson Valley includes improving the viability of small farm parcels which are not large enough to support the infrastructure that relies solely on hay and cattle operations.
